1. Eligibility Criteria: -

Experience of having successfully completed similar works during last 2 years ending **31.07.2008**.

Similar works will be considered as breaking of rock/stone in quarry, stacking of stone and loading in trucks/dumpers for transportation to crusher plant site.

2. Submission of offer :

- Agency shall submit his offer in two envelopes marking "Envelop No. 1 (Technical Bid)". Envelope No. 1 shall contain EMD and documents in support of Eligibility of the agency as per para No. 1 above.
- Envelope No. 2 marked "Price Bid" shall contain the signed MOU and the Financial Offer. Financial Offers of those agencies shall be opened who meet the eligibility criteria.
- Envelops containing "Technical Bid" and "Price Bid" shall be put together in one marked "Offer for Tender No. _____"

3. EMD:

Interested party should deposit EMD equal to 0.25% of the total value of package.

4. Machinery:

Agency should submit a list of tools & machinery available with the agency.

5. Experience:

Experience of similar works i.e. breaking of rock/stone in quarry, stacking of stone and loading in trucks/dumpers for transportation to crusher plant site.

6. Terms & Conditions:

All the terms and conditions of the NIT as prescribed in the Bidding tender documents shall be applicable.

7. Insurance:
