**1. Eligibility Criteria: -**

Experience of having successfully completed similar works during last 7 years ending **31.07.2008** should be either of the following: -

a. Three similar works each completed and each costing not less than 40% of the PAC cost

OR

b. Two similar works each completed and each costing not less than 50% of the PAC cost

OR

c. One similar work completed and costing not less than 80% of the PAC cost.

Similar work will be considered as Construction / Upgradation of Rural Roads / State Highways and National Highway.

**2. Submission of offer :**

- a) Agency shall submit his offer in two envelopes marking "Envelop No. 1 (Technical Bid)". Envelope No. 1 shall contain EMD and documents in support of Eligibility of the agency as per para No. 1 above.
- b) Envelope No. 2 marked "Price Bid" shall contain the signed MOU and the Financial Offer. Financial Offers of those agencies shall be opened who meet the eligibility criteria.
- c) Envelops containing 'Technical Bid" and "Price Bid" shall be put together in one marked "Offer for Tender No. \_\_\_\_\_"

**3. EMD:**

Interested party should deposit EMD equal to 0.40% of the total value of package.

**4. Machinery:**

Agency should submit a list of plant & machinery available with the agency.

**5. Experience:**

Experience of similar works i.e. Roads, Culverts and Cross Drainage Works

**6. Terms & Conditions:**

All the terms and conditions of the NIT as prescribed in the Bidding tender documents of client shall be applicable on back-to-back basis including all tax liabilities, except the conditions given in the "MOU" and "Terms & Condition".

**7. Insurance:**

TCIL shall take Insurance Policy as per requirement of the client. Cost of insurance @ 0.70 %of contract value shall be borne by the Agency.

**8. MOU:**

Agencies willing to participate shall sign the MOU which can be obtained from the Project Director concerned and submit the same along with their offer.
