### **1. Eligibility Criteria:-**

**1.3** Interested Agency (s) should have physically completed in last three financial years (i.e. current Financial year and three previous financial years) **at least one similar nature of work for a minimum value of Rs.34 Lakhs.**

**1.4** Interested Agencies should have required Plant and machinery as well as Technical personnel, skilled and unskilled labourers for deployment in the work for carrying out the work as per the specification and in a work man like manner within the time prescribed. **The time allowed for completing the work will be 270 days and will be essence of the contract.**

### **4. Cost of MOU Document**

The cost (non refundable) of MOU document is Rs.5,000/- inclusive of Sales Tax. This amount which is not refundable has to be remitted by means of DD from any Scheduled bank drawn in favour of **Telecommunications Consultants India Limited payable at Chennai.**
