TCIL is looking for entering into a pre-tender tie up and Memorandum of Understanding (MOU) from interested agencies experienced in Railway projects in Telecom cable works for carrying out the works of trenching, laying, jointing and termination of Telecommunication Cable and allied works in association with TCIL in the in the following section of Madurai Division of Southern Railway.

Agencies who fulfill the below mentioned eligible criteria and who are interested in working in association with TCIL may submit their '**Expression of interest**' along with completed offer for the work latest **by 15.00 Hrs. of 22/11/2011**. **1. Eligibility Criteria:-**

- 1.1. Interested Agency(s) should have physically completed in last three financial years (i.e. current Financial year and three previous financial years) at least one similar nature of work for a minimum value of Rs.28 Lakhs for the tender .
- 1.2. Interested Agencies should have required Plant and machinery as well as Technical personnel, skilled and unskilled labourers for deployment in the work for carrying out the work as per the specification and in a work man like manner within the time prescribed. The time allowed for completing the work will be 6 months and time will be essence of the contract.

**2. Cost of MOU Document**

The cost (non refundable) of MOU document is Rs.5480/- inclusive of Sales Tax. This amount which is not refundable has to be remitted by means of DD from any Scheduled bank drawn in favour of **Telecommunications Consultants India Limited payable at Chennai.**

- 2.1 Those who desire to purchase MOU document from this office can collect the same from this office between 10.00 Hrs. of 15.11.2011 and 14.00 Hrs. of 21.11.2011 by submitting the DD towards the tender cost viz.Rs.5480/- either in person or through authorized representative.

### 3 EMD:

EMD payable at the time of submission of MOU is Rs. 1,62,860/- which is refundable in case of unsuccessful applicant. EMD should be paid in the form of DD obtained from any scheduled bank and drawn in favour of **Telecommunications Consultants India Limited, payable at Chennai.**

4.2 The offer should be submitted in two envelopes:

1. **Envelope-1** (Eligibility) containing documents in supports of eligibility and experience, signed MOU and DD towards EMD as per clause-3.
2. **Envelope-2 (Rates).** Tenderer shall quote individual rates for items in the Schedule. The Tenderer has to quote the rates in figure and words for the individual items. The tenderer should quote prices inclusive of all the taxes and levies applicable as per prevailing tax laws from time to time.

**Earnest money in Envelope-1** will be opened first at **16.00 hrs of 22.11.2011** in the presence of those applicants present. Envelop-2 will be opened immediately after that and in the case of applicants who fulfill the eligibility and other terms and conditions as established by the documents furnished in Envelope- 1.
