#### **1. Eligibility Criteria:-**

**1.1** Interested Agency (s) should have physically completed in last three financial years (i.e. current Financial year and three previous financial years) **at least one similar nature of work for a minimum value of Rs.77 Lakhs.**

**1.2** Interested Agencies should have required Plant and machinery as well as Technical personnel, skilled and unskilled labourers for deployment in the work for carrying out the work as per the specification and in a work man like manner within the time prescribed. **The time allowed for completing the work will be 6 months and will be essence of the contract.**

#### **2. Cost of MOU Document**

The cost (non refundable) of MOU document is Rs.10960/- inclusive of Sales Tax. This amount which is not refundable has to be remitted by means of DD from any Scheduled bank drawn in favour of **Telecommunications Consultants India Limited payable at Chennai.**

**2.1** Those who desire to purchase MOU document from this office can collect the same from this office between 10.00 Hrs. of 22.11.2011 and 14.00 Hrs. of 01.12.2011 by submitting the DD towards the tender cost viz.Rs.10960/- either in person or through authorized representative.

**3. EMD:**

EMD payable at the time of submission of MOU is Rs. 2,59,820/- which is refundable in case of unsuccessful applicant. EMD should be paid in the form of DD obtained from any scheduled bank and drawn in favour of **Telecommunications Consultants India Limited, payable at Chennai.**

**4. Submission of offer:**

4.2 The offer should be submitted in two envelopes:

1. **Envelope-1** (Eligibility) containing documents in supports of eligibility and experience, signed MOU and DD towards EMD as per clause-3.
2. **Envelope-2 (Rates).** Tenderer shall quote individual rates for items in the Schedule. The Tenderer has to quote the rates in figure and words for the individual items. The tenderer should quote prices inclusive of all the taxes and levies applicable as per prevailing tax laws from time to time.

Envelope-1 will be opened first **at 16.00 Hrs of 02.12.2011** in the presences of those applicants present. Envelop-2 will be opened immediately after that and in the case of applicants who fulfill the eligibility and other terms and conditions as established by the documents furnished in Envelope- 1.
