1. Eligibility Criteria: -

Experience of having successfully completed similar works during last 7 years ending 31.12.2010 should be either of the following:-

a. Three similar works completed and each costing not less than 40% of the PAC Cost.

OR

b. Two similar works completed and each costing not less than 50% of the PAC Cost.

OR

c. One similar works completed and each costing not less than 80% of the PAC Cost.

Similar work will be considered as work executed for State Highway and National Highway.

2. Submission of offer :

- a) Agency shall submit his offer in two envelopes marking “Envelop No. 1 (Technical Bid)”. Envelope No. 1 shall contain EMD and documents in support of Eligibility of the agency as per para No. 1 above.
