**1. Eligibility Criteria: -**

**A. QUALIFICATION REQUIREMENTS**

Application are hereby invited from reputed agencies for Preparation of DPR for Trauma Centres in a 9 districts of Bihar (Namely Kishanganj, Purnia, Madhepura, Darbhanga, Muzaffarpur, Gopalganj, Jhanjarpur, Rohtas & Gaya )

1. The firm should have been in the field of execution of preparation of DPR for at least 15(fifteen) years.
2. The firm should have an ISO certification.
3. Average Annual Turnover of the firm during the last 3 years ending 31<sup>st</sup> March of the previous financial year, should be at least Rs. 57.6 lakhs.

4. Experience of having successfully completed similar works during last 7 years ending **31<sup>st</sup> March 2010** should be any of the following.
