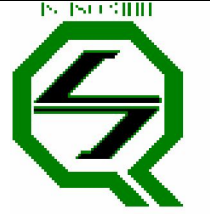

3. The location & movement of vehicles shall be as under:

  - (ii) XYLO (A.C.) - Jabalpur & Travelling within M.P.
  - (iii) Bolero (Non AC) - Vidisha/Bina
  - (iv) Scorpio (A.C.) - Vidisha/Bina
4. All Road Tax / Entry Tax / Road Permit & any other taxes shall be borne by the supplier.
5. Night charges shall be paid during stay outside above locations.
6. The daily run of vehicle shall be 10 hours & after that overtime shall be paid.
7. Entire Drivers expenses including salary / food etc shall be borne by supplier.
8. Toll taxes, if any, shall be paid by TCIL on production of receipt.
9. The vehicles are required for whole month without any break & agency shall replace driver on duty in case of leave.
10. One day break shall be considered for general mtc of vehicle during the month.
11. The agency is free to quote for one or more than one vehicle.
12. The offers shall remain valid for 60 days from the date of tender.

13. Payment shall be released from TCIL Vidisha office within 7 days of submission of duly verified bills.
