1. Eligibility Criteria: -

A. QUALIFICATION REQUIREMENTS

Application are hereby invited from reputed contractors for Supply of equipment in Trauma Centre in Bihar.

The firms which fulfill the following conditions are eligible to apply.

1. The firm should have been in the field of Supply of equipment in Trauma Centre in Bihar for at least 15 (fifteen) years.
2. The firm should have an ISO certification.
3. Average Annual Turnover of the firm during the last 3 years ending 31st March of the previous financial year, should be at least Rs.15.00 Crores.

4. Experience of having successfully completed similar works during last 7 years ending **31st March 2010** should be any of the following.
- a. Three similar works each costing not less than Rs.12.00 Crores.
- OR
- b. Two similar works each costing not less than Rs.15.00 Crores.
- OR
- c. One similar work completed not less than Rs.24.00 Crores.

5. Submission of offer:

Agency shall submit their offer as follows: - marking "Envelop No. 1 (Technical Bid)". Envelope No. 1 shall contain EMD and documents in support of Eligibility of the agency as per para No. 1 above.

6. EMD:

Interested party should deposit EMD of Rs. 12,00,000/- in the form of DD/FDR/BG from a scheduled bank.

7. Manpower:

Agency should submit the details in the enclosed forms (Form A- to Form -H).

8. Experience:

Experience of similar works i.e. above said works.

9. Terms & Conditions:
