TCIL intends to participate in the tender for Procurement of Emergency Triage Equipments for a Client in Ethiopia. TCIL invites Techno–Commercial offers from reputed Original Equipment Manufacturers (OEM's) for a Pre tender tie up with TCIL as the Prime bidder for submitting the bid in the tender.

### **ELIGIBILITY CRITERIA:**

Qualification requirements for OEM's are:

1. The Bidders / OEM's must provide evidence that the Medical Equipments and supplies offered has either interim or full approval by Standard or control authorities. A valid quality system certificate issued by a recognized certifying authority (e.g. ISO, DIN, TUV, BSI, etc.) should be submitted.
2. Bidders / OEM's must provide installation, training, after sales service, this must be confirmed with a separate letter along with the quotation. If the local agent is to provide installation, training and after sales service, authorization from OEM is to be provided for the above indicated after sales services.
3. Only original catalogues with detailed specification are accepted. The model described in the quotation must be similar to the model described with the attached catalogue and the manual attached. Any mismatch will result in the rejection of the bid.
4. Bidders / OEM's must provide list of important spare parts and accessories with their part number and costing along with the quotation. Failure to do so will result in the rejection of the bid.
5. Bidders / OEM's must submit user manual, installation manual and/or maintenance manual in hard copy and/or Soft Copy.
6. The following documents must be included with the bid
  - (i) that, in the case of a Bidder offering to supply Goods under the Contract that the Bidder does not manufacture or otherwise produce,(using ingredients supplied by primary manufacturers) that the Bidder:
    - (a) is incorporated in the country of manufacturer of the Goods;
    - (b) has been licensed by the regulatory authority in the country of manufacturer to supply the Goods.
  - (ii) that, in the case of a Bidder offering to supply Goods under the Contract that the Bidder does not manufacture or otherwise produce, that the Bidder has been duly authorized by a manufacturer of the Goods that meets the Criteria under (i)above the supply the Goods in the Purchaser's country; and

7. The Bidder/OEM shall also submit the following additional information:
  - (i) A statement of installed manufacturing capacity;
  - (ii) Copies of its audited financial statements for the past three fiscal years;
  - (iii) Details of on-site quality control laboratory facilities and services and range of tests conducted;
  - (iv) List of major supply contracts conducted within the last five years
  
8. The Bidders / OEM's shall have successfully completed or substantially completed three (3) similar contracts for the supply of similar goods within the last five (5) years. Similar contracts are those of approximately the same size and that includes comparable products, e.g., medical equipments and distribution services (if applicable).

The amount of Annual Sales Value required should be at least five (5) times the estimated contract value during the last five (5) years.

Bidders (and/or the Manufacturer of the goods) should have manufactured and marketed similar goods subject of bidding for at least five (5) years.

Bidders / OEM's must provide names of countries to which the Bidder/OEM has supplied (including packaged, transported and distributed) products within the past three (3) years
  
9. Experience and Technical Capacity: Having successfully completed a minimum of two contracts each of similar nature and size within the last five years.

Financial Capability: A minimum average annual turnover of two times the bid price offered, over the last five years.
  
10. Documentary evidence of the Bidder's / OEM's qualifications to perform the Contract if its bid is accepted:
  - (i) has a Good Distribution Practice (GDP) Certificate where appropriate.
  
11. The Bidders / OEM's will submit the following additional information:
  - (i) List of medical equipments being manufactured by the Bidder with product registration/license number and date.
  - (ii) A Certificate of the Product as recommended by the standard or control authority for the item offered.
  - (iii) In case of trade house; supplier should have the manufacturer authorization for supply of its products
