

NOTICE INVITING TENDER

Sealed tenders are invited from eligible/experienced contractors for **the Work of Execution of Public Health work Component for Construction of housing project in Sector 63, Chandigarh**

Tender documents shall be available from the office of **Project Director, TCIL, House No. 498, Phase X, Sector 64, Mohali** on payment of non-refundable fee of Rs. 1000.00 by Demand Draft in favour of **“Telecommunications Consultants India Ltd”** payable at **New Delhi/ Chandigarh**.

The documents downloaded by the parties from the website shall be valid for participation in the tender process. Those making use of the tender documents downloaded from the website shall have to pay the fee of the document in the form of a Demand Draft of Rs. 1000.00 towards tender cost along with Technical Offer. Tenders received without the requisite fee shall be considered as invalid ab-initio.

Eligibility criteria:

Bidder must provide necessary supporting documents as proof in respect of the eligibility criteria mentioned below:

1. Average Annual Financial Turnover during last 3 years ending 31st March 2011 should be at least 50% of the estimated cost of the work.
2. Experience of having successfully completed similar works during last 7 years ending 31ST Dec 2011 should be either of the following:
 - a) 3 (Three) Public Health works each costing not less than Rs.71 Lakhs or 3 (Three) Building Civil works including Public Health works each costing not less than Rs.240 Lakhs.
OR
 - b) 2 (Two) Public Health works each costing not less than Rs.89 Lakhs or 2 (Two) Building Civil works including Public Health works each costing not less than Rs.300 Lakhs.
OR
 - c) 1 (One) Public Health works each costing not less than Rs.143 Lakhs or 1 (One) Building Civil works including Public Health works each costing not less than Rs.480 Lakhs.
3. Bidder should not be blacklisted / debarred by any Government / Semi Government Department / PSU. (Please attach an undertaking (self certification on bidders letter head) that the bidder is not blacklisted by any Government Department / PSU).
4. Bidder should give undertaking that Plumber license will be submitted when required.

- d) Original purchased/downloaded tender document duly signed and stamped on all pages.
