1. ELIGIBILITY CRITERIA

- iv) Average Annual Financial Turnover of the bidder/OEM during the last 3 years, ending 31st March, 2011.
- v) Experience of having successfully supplied a similar plants and equipments within the delivery period specified in their Customers Purchase Order(s) in a period of 2 years ending 31st march, 2011 in respect of the items being quoted.

Bidder should provide necessary supporting documents as proof in respect of all the above items as part of eligibility verification.

Similar work/supply means supply, installation and commissioning of plants and machineries of similar or higher capacity mentioned in the BOQ.
